State Supplied Product - Must meet State eligibility criteria

State Supplied Vaccines for Children (DTaP, IPV, MMR, Var, Hep A, Hep B, MCV4, PCV, flu, HPV, RV, HIB, PPSV, Td, Tdap)	Vaccine supplied thru the Texas Vaccine for Children (TVFC) Program at no charge - must meet eligibility criteria. The TVFC program is for children 18 years and under.	The May 17, 2016 memo from the DSHS Immunization Branch Manager "Effective immediately, the maximum administration fee that the Texas Vaccines for Children (TVFC) providers may charge an eligible TVFC patient who does not have Medicaid or Children's Health Insurance (CHIP) coverage will be up to the maximum of \$14.85 per dose." And "service cannot be denied due to the parent's guardian's inability to pay the administration fee".	\$14 for one shot \$25 for 2 or more shots
State Supplied Adult Safety Net Vaccines (Td, Tdap, MMR, Hep A, Hep B, HPV, MCV4, Var, Shingles, PPSV, PCV)	Vaccine supplied thru the Adult Safety Net Program at no charge – must meet eligibility criteria. For adults 19 years and up as available.	Mimics the administration fee for children's TVFC vaccine.	\$14 for one shot \$25 for 2 or more shots

GCHD's Privately Purchased Vaccine

“You will be charged the Vaccine Fee + Administration Fee. The Administration Fee is \$14 for one shot and \$25 for two or more. A Cash Discount of \$5 for each vaccine will be given if you pay with cash, check, credit or debit card (no insurance billed).”

Adult Hepatitis A Vaccine	For Adults who do not meet the eligibility criteria for the State supplied, Adult Safety Net vaccine	Cost of purchasing the vaccine	\$75 plus admin fee
Pneumococcal Polysaccharide Vaccine (PPSV23)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$105 plus admin fee
Measles, Mumps and Rubella Vaccine (MMR)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$80 plus admin fee
Influenza Vaccine	For clients 6 months and older that do not fit the criteria for state supplied vaccine	Cost of purchasing the vaccine	\$25 plus admin fee
Meningitis Vaccine (MCV4)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$130 plus admin fee
Human Papillomavirus (HPV9)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$225 plus admin fee
Shingles (Shingrix)	For clients 50 years and older who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$155 plus admin fee
Tdap (Tetanus, diphtheria, pertussis)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$60 plus admin fee
Varicella (Chickenpox)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$135 plus admin fee
DTaP (Diphtheria, Tetanus, Pertussis)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$45 plus admin fee

Kinrix (DTaP and IPV)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$65 plus admin fee
Pediatric Hep A Vaccine	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$45 plus admin fee
Pediatric Hep B Vaccine	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$35 plus admin fee
Hib Vaccine	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$20 plus admin fee
Rotavirus Vaccine	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$95 plus admin fee
Pediarix (DTaP, IPV, Hep B)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$90 plus admin fee
Pentacel (DTaP, IPV, Hib)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$100 plus admin fee
Proquad (MMRV)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$225 plus admin fee
Prevnar (PCV13)	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$200 plus admin fee
Td	For clients who do not meet the eligibility criteria for State supplied vaccine.	Cost of purchasing the vaccine	\$45 plus admin fee

Other Items

Service/Item	Description	Fee Basis	Vaccine Fee
Rabies Vaccine Pre -exposure	For clients at high risk of contracting rabies according to CDC guidelines (animal handlers, veterinarians, at risk lab workers). This pre-exposure vaccination consists of a series of 3 vaccines.	Cost of purchasing the vaccine as of August 13, 2013 current cost can be approximately \$900 or more for 3 shot series.	Actual cost at the time of purchase plus administrative fee
*Admin Fee for Rabies Vaccine Post-Exposure	For clients after a rabies exposure, series of 4 vaccines, when the client brings their own vaccine supplied from DSHS	Mimics the administration fee for private vaccines	\$14 per dose
*Admin Fee for Rabies Immune Globulin (IG)	For clients after a rabies exposure to provide immediate, temporary immunity, when client brings their own IG supplied from DSHS	Mimics the administration fee for private vaccines	\$14 per dose
PPD (Tuberculin Skin Test)	For clients who do not meet the criteria for state supplied PPD	Cost of purchasing the test, mimics administration fee and cash discount for private vaccines	\$20 plus administrative fee
Rapid HIV testing	To meet the public demand for convenient HIV testing at an affordable cost to clients	Cost of HIV Test Kit, plus administrative fee	\$30

***If DSHS does not have rabies biologicals, post-exposure vaccine and immunoglobulin will be available at cost plus an administration fee at the time of need.**

****When necessary, new fees will be established by the CEO (or designee) to cover GCHD costs for purchased vaccine or biologicals in unplanned circumstances warranting the protection of public health from the spread of a communicable disease.**
